

## FEE SCHEDULE 2024

*Payment for all services is due immediately following the session unless prior arrangements have been made.*

### INTAKE SESSIONS ~ \$380

Inclusive of a therapeutic plan (90-minute session & 30 minutes casework)

Intake Session includes a thorough session, getting to know you and your child, your family system, developmental history and the formation of a treatment plan and goals. An intake session is required before the commencement of therapy. Intake sessions are completed with the parent and carers only. ***We ask that children NOT attend this session.*** An intake form will be emailed to you and must be completed before our intake session.

### INDIVIDUAL PLAY THERAPY/COUNSELLING SESSION ~ \$190

Standard Session (45-minute Play Therapy session & 15 minutes casework)

Sessions are completed at our Curious Box Playroom. For the greatest therapeutic gains, we recommend that these sessions occur weekly. This will be discussed in detail during the intake session.

### GROUP OR SIBLING THERAPY SESSION ~ \$100 PER CHILD

Standard Session (45 minutes Play Therapy session & 15 minutes casework).

Sessions are completed at our Curious Box Playroom.

### PROGRESS/REVIEW/CLOSURE SESSION ~ \$190

45-minute session & 15 minutes casework

Progress update sessions occur every 4 to 5 standard child-centred play Therapy sessions with the primary caregiver. Ongoing Progress and Parent Support Sessions are completed in person or by phone.

### ADDITIONAL COSTS OR REQUESTS

## CANCELLATION POLICY

We get that life happens! Where possible, we ask that you notify Curious Box by email, phone or SMS that you cannot attend to avoid any cancellation fees.

Under the No-Show Policy (non-attendance), 100% of the fees will be charged. If participants are more than 15 minutes late for the appointment, the appointment will be charged as non-attendance and will not go ahead. Participants must be available for the full duration of the session to ensure the greatest therapeutic impact.

Short Notice Cancellation (within 48 hours) will be charged 75% of the service fee.

If cancellations/no-shows occur three appointments in a row, a review will be completed to see if continued service is appropriate for the child/or family.

Cancellation by Therapist- If your therapist cannot attend a session for any reason, you will not be charged for the session.

## CONFIDENTIALITY AND PRIVACY AGREEMENT

We maintain strict confidentiality regarding all information provided to us, including personal and medical information. The only time we will disclose information to relevant authorities is if there is a risk of harm to you or your child. Where safe to do so, we would discuss any potential disclosure with you unless our safety is at risk.

With Play Therapy sessions, we keep the information between the child and therapist confidential and cannot discuss the specifics. However, we can provide progress updates and discuss any themes present and any significant concerns with you.
